Membership Categories:

☐ **Adult:** A person who is nineteen years of age or older as of July 1, is a current member of AMA; and paid current with all club dues and fees. Adult members may hold club office; may vote on all club issues before the general membership and has flying privileges within the current flight rating.

☐ **Youth:** A person who is nineteen years of age or younger as of July 1, is a current member of the AMA, and paid current with all club dues and fees. Junior members may vote on all club issues before the general membership and has flying privileges within current flight rating.

☐ **Family member:** Current spouse, and any children under 19 years of age as of July 1, of a paid up regular adult member. Each family member desiring flying privileges shall be a current member of the AMA, and shall have flying privileges after solo qualification as determined by an Association flight instructor. Dependent family members must be living at home and /or be a full time student. The fee is \$10.00 per person per year.

☐ **Associate:** members that have, and can produce proof of a current, paid, primary regular membership in good standing in another AMA chartered club. Flying privileges require a current AMA membership. Associate members may not vote on any club issues or ballot; may not hold club office but can serve on club committees.

☐ **Auxiliary:** A person who desires to be involved with MMAA but does not wish to vote, hold elected office or have flying privileges. Auxiliary members may serve on any committee but shall not have privileges or duties of a regular member.

☐ **Partial Year:** This is available to new members only. When joining for a partial year the dues are calculated from the month joined to the end of the year at the rate of \$20.00 per month. This partial year membership is available once per person.
